

**CONSENT AGREEMENT  
BETWEEN  
WILLIAM A. MOSIER  
AND THE  
STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND  
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between WILLIAM A. MOSIER, hereinafter, "**MOSIER**," and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "**BOARD**," the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

**MOSIER** hereby acknowledges that he has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the **BOARD** or any of its members, employees or agents.

**MOSIER** is fully aware of his rights, including his right to be advised by counsel and his right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. Should **MOSIER** fail to comply with any provisions of this CONSENT AGREEMENT, **MOSIER** knowingly waives his rights under ORC Chapter 119 to a hearing.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. **MOSIER** is an independent marriage and family therapist (F.0000004) licensed to practice marriage and family therapy in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of marriage and family therapy as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. **MOSIER** received his independent marriage and family therapist license on April 6, 2004.
2. **MOSIER** applied for licensure as an independent marriage and family therapist on or about January 2004. As part of that application, **MOSIER** answered "No" to Question #21 which asked if he had ever

been the subject of disciplinary action by any licensing agency.

3. **MOSIER** was disciplined on or about December 13, 2000, by the State of Florida Board of Medicine for having "a license or the authority to practice medicine .....by the licensing authority of any jurisdiction, including its agencies or subdivisions, in that" **MOSIER'S** "license was acted against by the Physician Assistant Advisory Council of the Texas Board of Medical Examiners on June 14, 1995".
4. **MOSIER** admits the allegations referenced in paragraphs 2 and 3 referenced above, but believed at the time of making his Ohio application that the Florida action was an administrative action as opposed to a disciplinary action because he was not sanctioned or required to pay a fine. **Mosier** only paid administrative costs pertaining to the investigation of the allegations.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal disciplinary proceedings, **MOSIER** knowingly and voluntarily agrees with the **BOARD** to the following terms and conditions:

1. **MOSIER** must take six (6) hours of continuing education in the area of professional ethics in the area of mental health services. These hours must be pre-approved in writing by the Board's Deputy Director or his designee. After **MOSIER** completes these hours, he must submit a copy of his attendance certificate(s) to verify his attendance for these hours. These hours must be completed and verification submitted no later than January 31, 2009. The credit earned from these hours may not be used toward the thirty (30) hours of continuing education required for license renewal. All costs associated with the course are at the expense of **MOSIER**.
2. Should **MOSIER** take a position that requires the practice of marriage and family therapy, **MOSIER** must receive face-to face supervision, by an individual pre-approved by the Board, one-hour every week for a period of 1 year when he is employed as a marriage and family therapist. This provision will not be applicable when **MOSIER** is serving in an official capacity with the US Dept. of Defense. **MOSIER** should not select a supervisor with which he has a prior relationship. If any previous relationship with the supervisor exists, **MOSIER** must provide full disclosure of such a relationship in the request for supervisor approval. The 1-year supervision period will not begin until **MOSIER'S** supervisor is approved by the Board. Supervision should focus on, but not limited to, **MOSIER'S** role in professional relationships and ethical decision-making. **MOSIER'S** supervisor is required to submit a report to the Board, quarterly, detailing topics discussed during supervision sessions, areas of concern, and areas for improvement. At the end of the 1-year supervised period, **MOSIER'S** supervisor will make a final report encompassing the year of supervision. If **MOSIER'S** supervisor is concerned with **MOSIER'S**

practice at any time the Board should be notified immediately. It is **MOSIER'S** responsibility to ensure that the Board receives the supervisor's reports. This requirement will cease as of November 1, 2009. All costs, if any, associated with the supervision are at the expense of **MOSIER**.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By his signature on this **CONSENT AGREEMENT**, **MOSIER** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **MOSIER** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, he will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.


**MOSIER** hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61, and Ohio Revised Code 3123.41 et seq., the **BOARD** may be required to provide **MOSIER'S** social security number to requesting governmental agencies.


The **BOARD** shall incorporate this **CONSENT AGREEMENT** into a formal journal entry at its September, 2008, meeting.

Consent Agreement between William A. Mosier and the State of Ohio Counselor, Social Worker, Marriage and Family Therapist Board


