**CONSENT AGREEMENT  
BETWEEN  
MARSHA MANON  
AND THE  
STATE OF OHIO COUNSELOR, SOCIAL WORKER AND MARRIAGE AND  
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between MARSHA MANON, hereinafter, "MANON," and the STATE OF OHIO COUNSELOR, SOCIAL WORKER AND MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "BOARD," the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

MANON hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

MANON is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulation, admission and understanding:

1. MANON is a professional clinical counselor with the supervision credential (E.0003860) licensed in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. MANON received her professional clinical counselor license on November 22, 2002 and her supervisory credential on April 30, 2007.
2. Between February 26, 2011 and March 2, 2011 MANON, while employed by COMPASS Corporation for Recovery Services, Toledo, OH did condone, partake and assist in billing irregularities or fraud with respect to insurance companies or direct billing. MANON inaccurately recorded start and end times on three (3) separate patient progress notes. This act constitutes a violation of Ohio Revised Code Section 4757.36(C) (1) and Ohio Administrative Code Section 4757-5-09(G).
3. MANON ADMITS the allegations referenced in paragraph 2 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, **MANON** knowingly and voluntarily agrees with the **BOARD** to the following terms and conditions:

1. **MANON'S** license to practice clinical counseling is **REPRIMANDED**.
2. **MANON'S** supervisory credential is suspended for eighteen months (18) months. Upon the end of the eighteen month suspension **MANON** may have the supervisory credential re-instated. **MANON** must continue to obtain the continuing education requirements and renew the supervisory credential if she wishes to have the credential re-instated.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **CONSENT AGREEMENT**, **MANON** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **MANON** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.

**MANON** hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61 and Ohio Revised Code Section 2301.373(E), the **BOARD** may be required to provide **MANON'S** social security number to requesting governmental agencies.

The **BOARD** shall incorporate this **CONSENT AGREEMENT** into a formal journal entry at its January 20, 2012 meeting.

This **CONSENT AGREEMENT** shall take effect upon the date of the last signature below:
