### **FINDINGS, ORDER, AND JOURNAL ENTRY**

This matter came for consideration after a Notice of Opportunity for Hearing was issued to Barbara Jo Manges by the Counselor, Social Worker, and Marriage and Family Therapist Board on July 22, 2005. An administrative hearing was held on January 26, 2006, at 9:30 a.m. in the offices of the Ohio Counselor, Social Worker, and Marriage and Family Therapist Board, 50 West Broad Street, Columbus, Ohio 43215, pursuant to Chapter 119 and Section 4757 of the Ohio Revised Code. The State was represented by Assistant Attorney General Peter R. Casey, IV. Barbara Jo Manges was present and represented by legal counsel, Jeffrey Jurca.

The Social Worker Professional Standards Committee has reviewed the Hearing Officer Report and Recommendations prepared in this case following the administrative hearing. The Committee also reviewed the objections to the hearing officer report filed by Mr. Jurca on behalf of his client. The transcript and evidence were made available to the Committee to review. Both Mr. Jurca and Mr. Casey were given the opportunity to address the Committee before the Committee went into executive session to discuss the case. The Committee finds that Ms. Manges violated Ohio Revised Code Section

4757.36(A)(1) and Ohio Administrative Code Sections 4757-5-01(B)(1)(a) and 4757-21-04(B)(2)(d)(i). The Committee accepts the Findings of Fact and Conclusions of Law presented in the Hearing Officer Report and Recommendations in their entirety. The Committee modifies the Recommended Order of the Hearing Officer Report and Recommendations by the following:

The Committee Orders the following with regard to Ms. Manges' license to practice social work (I-0003887):

1. Ms. Manges' license to practice social work is Reprimanded.
2. Ms. Manges must take six (6) clock hours of continuing social work education in the area of professional ethics. These clock hours must be pre-approved in writing by the Board's Deputy Director or his designee. After Manges completes these hours, she must submit a copy of her attendance certificate(s) to verify her attendance for these hours. These hours must be completed and verification submitted no later than January 31, 2007. The credit earned from these hours may not be used toward the thirty (30) hours of continuing education required for license renewal. All costs associated with the clock hours are at the expense of Manges.

This ORDER was approved by unanimous vote of the Members of the Committee who reviewed this case. Dr. Theresa Cluse-Tolar did not participate in the discussion or the vote on this case.

Motion carried by order of the Social Worker Professional Standards Committee of the Ohio Counselor, Social Worker, and Marriage and Family Therapist Board.

### APPEAL RIGHTS

Under the provisions of Ohio Revised Code Section 119.12, any party adversely affected by an order of an agency issued pursuant to an adjudication denying an applicant admission to an examination, or denying the issuance or renewal of a license or registration of a license, or revoking or suspending a license, may appeal from the order of the agency to the court of common pleas of the county in which the place of business of the licensee is located or the county in which the licensee is a resident. If any such party is not a resident of and has no place of business in Ohio, the party may appeal to the court of common pleas of Franklin County

This *Order* may be appealed in accordance with Section 119.12 of the Ohio Revised Code by filing the original Notice of Appeal with the Ohio Counselor, Social Worker, and Marriage and Family Therapy Board, 50 West Broad Street, Suite 1425, Columbus, Ohio 43215, and also a copy of that Notice of Appeal with the Court of Common Pleas in the county of the party's place of business, or in the county in which the party is a resident. The Notice of Appeal shall set forth the Order appealed from and the grounds

of the Party's appeal. Such Notice of Appeal and copy shall be filed and must be delivered within fifteen (15) days after the mailing of this *Adjudication Order*.
