
By letter dated April 18, 1994, notice was given to Carolyn Lander, LSW, that the Counselor and Social Worker Board intended to consider disciplinary actions regarding her license to practice as a Licensed Social Worker in Ohio, and that she was entitled to a hearing if such a hearing was requested within thirty (30) days of the mailing of said notice. In accordance with section 119.09 of the Ohio Revised Code, said notice was sent via certified mail, return receipt requested, to the last know address of Carolyn Lander, LSW, that being 6180 Dayton Liberty Road, Dayton, OH 45418.

Ms. Lander has not requested a hearing.



In accordance with Chapter 119 and Chapter 4757 of the Ohio Revised Code, you are hereby notified that the State of Ohio Counselor and Social Worker Board intends to determine whether to issue a reprimand, or suspend or revoke your license to practice as a social worker. The Board proposes this action for the following reasons:

- A. You were licensed as a Licensed Social Worker (LSW) on September 12, 1987. Your LSW license expired on September 12, 1989. You never renewed your LSW license.

On or about September 28, 1990, you applied for a job as a Youth Service Specialist at Agape for Youth, Inc., located in Dayton, Ohio. This job required that you be an LSW or Licensed Professional Counselor (LPC). In applying for this job, you held yourself out as being an LSW.

In fact in 1990 you were not licensed as a Licensed Social Worker as your license was expired at that time.

Your actions as described above constitutes a violation of Ohio Revised Code 4577.02(B), (C) and Ohio Administrative Code 4757-21-01(B), to wit: R.C. 4757.02(B),(C) and Ohio Administrative Code 4721-21-01(B)(6).

- B. During your employment as a Youth Service Specialist for Agape for Youth, Inc., from 1990 to the present, you signed documents representing yourself as an LSW when in fact your license was expired.

Your actions as described above constitutes a violation of Ohio Administrative Code 4757-19-01(D) and 4757-21-01(B)(6).

You are entitled to a hearing in this matter if you request such a hearing within thirty (30) days of the date of mailing of this notice. You are entitled to appear at such hearing in person, or by your attorney, or to present your position, arguments, or contentions in writing, and at the hearing you may request evidence and examine witnesses appearing for or against you.

In the event that there is no request for such a hearing made within thirty (30) days of the date of mailing of this notice, the State of Ohio Counselor and Social Worker Board may, in its discretion, issue a reprimand to you or suspend or revoke your license or may deny application for renewal.


