**CONSENT AGREEMENT
BETWEEN
DEANNA L. DOMIGAN
AND THE
OHIO STATE COUNSELOR AND SOCIAL WORKER BOARD**

This CONSENT AGREEMENT is entered into the and between DEANNA L. DOMIGAN, hereinafter, "**DOMIGAN**", and the OHIO STATE COUNSELOR AND SOCIAL WORKER BOARD, hereinafter "**BOARD**", the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated thereunder.

DOMIGAN hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the **BOARD** or any of its members, employees or agents.

DOMIGAN is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. **DOMIGAN** is a Social Worker (S-13497) licensed to practice social work in the state of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in O.R.C. Chapter 4757.
2. **DOMIGAN** first became licensed as a social worker by the **BOARD** on February 1, 1992. **DOMIGAN'S** license to practice social work lapsed on February 2, 1996, and remained in a lapsed status until February 26, 1997.
3. During the period of time that **DOMIGAN'S** license had lapsed, **DOMIGAN** was employed as a social worker at Project Woman in Springfield, Ohio

4. **DOMIGAN'S** practicing social work on an expired license is a violation of O.R.C. 4757.13 (A) and O.A.C. 4757-7-02.
5. **DOMIGAN ADMITS** the facts referenced in paragraphs 1 through 4 referenced above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal disciplinary proceedings, **DOMIGAN** knowingly and voluntarily agrees with **BOARD** to the following terms and conditions:

- A. **DOMIGAN** is hereby **REPRIMANDED** by the **BOARD**. Such **REPRIMAND** will be recorded in **DOMIGAN'S** permanent licensure file with the **BOARD** for violating the Ohio Revised Code and Ohio Administrative Code sections referenced in paragraph 4 above.
- B. **DOMIGAN** agrees to take and pass a graduate level social work ethics course, pre-approved by the **BOARD**, for credit. **DOMIGAN** will have until December 1998 to complete this requirement. At the end of the course, **DOMIGAN** will provide to the **BOARD** an official copy of the school transcript showing the passing grade and the credits earned. The credits for this course will NOT be allowable towards licensure renewal.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **AGREEMENT**, **DOMIGAN** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **DOMIGAN** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the

BOARD was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.

DOMIGAN hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code.


The **BOARD** shall incorporate this **CONSENT AGREEMENT** into a formal journal entry at its September, 1997, meeting.
