

Terms of the consent agreement  
complete as of 6/13/1995

CONSENT AGREEMENT  
BETWEEN  
MYLO G. JENNINGS  
AND

THE STATE OF OHIO COUNSELOR AND SOCIAL WORKER BOARD

This CONSENT AGREEMENT is entered into by and between MYLO G. JENNINGS (hereinafter "MR. JENNINGS") and the STATE OF OHIO COUNSELOR AND SOCIAL WORKER BOARD ("hereinafter "BOARD"), the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code, and all rules promulgated thereunder.

MR. JENNINGS hereby acknowledges that he has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

MR. JENNINGS is fully aware of his rights, including his right to be advised by counsel on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following statements and understandings:

1. MR. JENNINGS is licensed as a Licensed Social Worker in the State of Ohio. His license was issued on February 1, 1992, and his license is current.
2. Pursuant to Ohio Revised Code 4757.13(A), and Ohio Admin. Code 4757-27-01(C), the BOARD may refuse to issue, revoke or suspend any license it has issued if the person has committed a violation of Chapter 4757 of the Revised Code or Rules adopted under it.
3. Ohio Revised Code Section 4757.09(A) states that "a social worker shall not engage in the private practice of social work as an individual practitioner or as a member of a partnership or group practice."
4. As of October 19, 1992, MR. JENNINGS did engage in the private practice of social work as a licensed social worker in violation of Ohio Revised Code 4757.09(A), in that he was the co-owner of the Child and Family Partnership Inc., 1 East Main Street, Norwalk, Ohio.

Based on the above statements and understandings the BOARD and MR. JENNINGS agree as follows:

- A. The Child and Family Partnership, Inc. will cease and desist all direct services as of February 1, 1993. At that time the corporation will be dissolved.
- B. MR. JENNINGS will not engage in the private practice of social work as an individual practitioner or as a member of a partnership or group practice unless he obtains licensure to do so.
- C. MR. JENNINGS is hereby REPRIMANDED for his conduct constituting violations of the Ohio Revised Code as outlined in paragraphs 4 and 6 of this CONSENT AGREEMENT.
- D. In exchange for the agreements of MR. JENNINGS set forth in this CONSENT AGREEMENT, the BOARD agrees it will not take formal disciplinary action other than what is contained in this CONSENT AGREEMENT, unless the terms of this CONSENT AGREEMENT are not complied with or are violated.
- E. MR. JENNINGS will, at six (6) month intervals beginning March 1, 1993 and continuing for a period of two years, ending March 1, 1995, submit to the Board information regarding his current employment status including job descriptions and professional disclosure statements. A total of five reports will be due by MR. JENNINGS in compliance with this agreement, due on March 1, 1993; September 1, 1993; March 1, 1994; September 1, 1994; and March 1, 1995.
- F. MR. JENNINGS agrees to take no legal action against the Board or its members, staff, or representatives regarding the circumstances leading up to and resulting in this CONSENT AGREEMENT.

In the event the BOARD, in its discretion, does not approve this CONSENT AGREEMENT, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43, Ohio Revised Code.

This CONSENT AGREEMENT is not an adjudication order within the meaning of Section 119.01(D), Ohio Revised Code.

The BOARD shall incorporate this CONSENT AGREEMENT into a formal Journal Entry at its next meeting after the time this agreement is executed by both parties.

This CONSENT AGREEMENT shall become effective when it has been signed by the parties and their representatives, as indicated below.




