**CONSENT AGREEMENT
BETWEEN

This CONSENT AGREEMENT is entered into by and between SAMUEL H. BOYD, JR., hereinafter, "BOYD," and the STATE OF OHIO COUNSELOR, SOCIAL WORKER AND MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "BOARD," the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

BOYD hereby acknowledges that he has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

BOYD is fully aware of his rights, including his right to be advised by counsel and his right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. Should BOYD fail to comply with any provisions of this CONSENT AGREEMENT, BOYD knowingly waives his rights under ORC Chapter 119 with respect to the claims in this agreement

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. **BOYD** is a social worker (S-0015831) licensed in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. **BOYD** received his social work license on November 21, 1992.
2. **BOYD** was employed at the Ohio Department of Youth Services,(ODYS), Freedom Center in Delaware, Ohio. On or about, June 7, 2004, ODYS, conducted an investigation regarding **BOYD**. It is alleged, **BOYD** engaged in inappropriate conduct with a client. This inappropriate conduct constitutes a violation of Ohio Revised Code Section 4757.36(A)(1) and Ohio Administrative Code Section 4757-5-01(B)(6).
3. **BOYD ADMITS** the allegations referenced in paragraph 2 above.

Consent Agreement between SAMUEL H. BOYD, JR. and the State of Ohio Counselor, Social Worker and Marriage and Family Therapist Board

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal disciplinary proceedings, **BOYD** knowingly and voluntarily agrees with the **BOARD** to the following terms and conditions:

1. **BOYD'S** license as a social worker is hereby **SUSPENDED** for a period of sixty (60) days beginning May 22, 2006.
2. **BOYD** is required to complete and pass a college or university course in social work ethics, at his expense. The course must be pre-approved by the **BOARD**. **BOYD** must contact the **BOARD'S** investigative unit to seek pre-approval. The course must be completed by May 31, 2007.
3. **BOYD** will be on probation for a period of six (6) months. During the six month probationary period **BOYD** must receive face-to-face supervision one hour every two weeks. **BOYD'S** supervisor must be pre-approved by the **BOARD** and should not have a prior relationship with **BOYD**. If a previous relationship exists, **BOYD** must provide full disclosure of such a relationship in the request for supervisor approval. All cost associated with supervision will be at **BOYD'S** expense. The request for supervisor approval must be made in writing, include a copy of the supervisor's vita and be submitted no later than two weeks after the signing of this consent agreement. Supervision should focus on, but not be limited to, multiple relationships with clients, sexual harassment and therapeutic techniques. Supervision should be considered training in nature and should not be limited to simply approving and denying case plans. **BOYD'S** supervisor must submit quarterly reports to the **BOARD** for the entire six month period detailing topics discussed during supervision sessions, areas of concern, areas of improvement and make a recommendation with regards to **BOYD'S** suitability to practice. However, if **BOYD'S** supervisor is concerned with **BOYD'S** practice at any time during the probationary period the **BOARD** should be notified immediately. It is **BOYD'S** responsibility to ensure that the **BOARD** receives all supervisory reports.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By his signature on this **CONSENT AGREEMENT**, **BOYD** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **BOYD** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case

proceeds to hearing, he will assert no claim that the BOARD was prejudiced by its review and discussion of this CONSENT AGREEMENT or of any information relating thereto.


BOYD hereby releases the members of the BOARD, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61 and Ohio Revised Code Section 2301.373(E), the BOARD may be required to provide BOYD'S social security number to requesting governmental agencies.

The BOARD shall incorporate this CONSENT AGREEMENT into a formal journal entry at its May 19, 2006 meeting.

This CONSENT AGREEMENT shall take effect upon the date of the last signature below:


