**CONSENT AGREEMENT  
BETWEEN  
SHANNON N. WOOD  
AND THE  
STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND  
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between SHANNON N. WOOD hereinafter, "**WOOD**", and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "**BOARD**", the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated thereunder.

**WOOD** hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the **BOARD** or any of its members, employees or agents.

**WOOD** is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. Should **WOOD** fail to comply with any provisions of this CONSENT AGREEMENT, **WOOD** knowingly waives her rights under ORC Chapter 119.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. **WOOD** is a social worker (S-22132) licensed to practice social work in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. **WOOD** received her social work license on September 22, 1995.
2. In 2002, while **WOOD** was employed at the Education Service Center, Pomeroy, Ohio, she blurred her professional boundaries by allowing a minor male client, whom she was professionally seeing in a school setting, to attend church services with her and her family and to stay in her personal residence after school. **WOOD'S** conduct constitutes a violation of Ohio Revised Code Section 4757.36(A)(1) and Ohio Administrative Code Section 4757-5-01(C)(1)
3. **WOOD ADMITS** the allegations referenced in paragraph 2 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal disciplinary proceedings, **WOOD** knowingly and voluntarily agrees with **BOARD** to the following terms and conditions:

1. **WOOD'S** license to practice social work is **SUSPENDED** from November 24, 2003, until December 31, 2003.
2. **WOOD**, at her own expense, must take for credit and a grade a social work ethics course from an accredited college or university. This course must be pre-approved by the **BOARD'S** investigative supervisor or his designee. This course cannot be a home-study or an on-line based course. Upon completion of this course, **WOOD** must arrange for the college or university to send an official transcript showing successful completion of this course to the **BOARD'S** Investigation Unit. **WOOD** will have until July 31, 2005, to complete this course and ensure the **BOARD** receives the required transcript. The credit hours **WOOD** receives for this course will not count toward her continuing education renewal requirements.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **CONSENT AGREEMENT**, **WOOD** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **WOOD** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.

If, following notice and an evidentiary hearing, **WOOD** is found by the **BOARD** to have violated any terms of this Consent Agreement, the **BOARD** may impose any penalty up to and including **REVOCAION** of **WOOD'S** social work license based solely upon a violation of this Consent Agreement. **WOOD** may not appeal this action.

**WOOD** hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61, and Ohio Revised Code Section 3123.41 et seq the **BOARD** may be required to provide **WOOD'S** social security number to requesting governmental agencies.

The **BOARD** shall incorporate this **CONSENT AGREEMENT** into a formal journal entry at its November, 2003, meeting.
