**CONSENT AGREEMENT
BETWEEN
DANIELLE FEEZLE
AND THE
STATE OF OHIO COUNSELOR, SOCIAL WORKER AND MARRIAGE AND
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between DANIELLE FEEZLE, hereinafter, "FEEZLE," and the STATE OF OHIO COUNSELOR, SOCIAL WORKER AND MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "BOARD," the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

FEEZLE hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

FEEZLE is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. Should FEEZLE fail to comply with any provisions of this CONSENT AGREEMENT, FEEZLE knowingly waives her rights under ORC Chapter 119 with respect to the claims in this agreement.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulation, admission and understanding:

1. FEEZLE is a social worker (S0024364) licensed in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. FEEZLE received her social work license on July 18, 1997.
2. Between June 1, 2006 and November 30, 2006, FEEZLE, while employed by Home For Kids, Inc., Niles, OH, failed to maintain sufficient and timely documentation in records to facilitate the delivery of services and to ensure continuity of services provided to clients in the future. This act constitutes a violation of Ohio Revised Code Section 4757.36(A) (1) and Ohio Administrative Code Section 4757-5-09(B) & (C).
3. Between June 1, 2006 and November 30, 2006 FEEZLE, while employed by Home for Kids, Inc., Niles, OH did condone, partake and assist in billing irregularities or fraud with respect to insurance companies or

direct billing. This act constitutes a violation of Ohio Revised Code Section 4757.36(A) (1) and Ohio Administrative Code Section 4757-5-09(G).

4. On February 24, 2009, **FEEZLE**, pled guilty to, theft, a fifth degree felony, in Franklin County Common Pleas Court, Columbus, OH. This act constitutes a violation of Ohio Revised Code Section 4757.36(A) (1) and Ohio Administrative Code Section 4757-11-01(C) (7).
5. **FEEZLE ADMITS** the allegations referenced in paragraph 2, 3 and 4 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, **FEEZLE** knowingly and voluntarily agrees with the **BOARD** to the following terms and conditions:

1. The **BOARD** will allow **FEEZLE** to permanently surrender her license. **FEEZLE** will not be allowed to reapply for a social work license in the State of Ohio, nor will she be allowed to apply for a counseling or marriage and family therapist license in the State of Ohio. This surrender will take effect May 15, 2009.

It is hereby agreed by and between both parties that this CONSENT AGREEMENT hereby settles all issues concerning this matter.

By her signature on this CONSENT AGREEMENT, **FEEZLE** acknowledges that in the event the **BOARD**, in its discretion, does not approve this CONSENT AGREEMENT, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **FEEZLE** agrees that should the **BOARD** reject this CONSENT AGREEMENT and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this CONSENT AGREEMENT or of any information relating thereto.

FEEZLE hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61 and Ohio Revised Code Section 2301.373(E), the **BOARD** may be required to provide **FEEZLE'** S social security number to requesting governmental agencies.

The **BOARD** shall incorporate this CONSENT AGREEMENT into a formal journal entry at its May 15, 2009 meeting.

This CONSENT AGREEMENT shall take effect upon the date of the last signature below:

**CONSENT AGREEMENT

AND THE

This CONSENT AGREEMENT is entered into by and between DANIELLE RODKEY-BAILEY, hereinafter, "**RODKEY-BAILEY**", and the STATE OF OHIO COUNSELOR AND SOCIAL WORKER BOARD, hereinafter "**BOARD**", the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated thereunder.

RODKEY-BAILEY hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the **BOARD** or any of its members, employees or agents.

RODKEY-BAILEY is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. **RODKEY-BAILEY** is a social worker (S-24364) licensed to practice social work in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757. **RODKEY-BAILEY** received her social work license on July 18, 1997.
2. While employed at Lincoln Place in Mahoning County, Ohio, **RODKEY-BAILEY** failed to maintain client records that were an accurate reflection of services provided. Failure to maintain accurate records constitutes a violation of Ohio Revised Code Section 4757.36(A)(1) and Ohio Administrative Code Section 4757-5-01(I)(1).
3. Also while employed at Lincoln Place, **RODKEY-BAILEY** practiced while her license was lapsed. Although **RODKEY-BAILEY'S** license lapsed July 18, 2001, **RODKEY-BAILEY** continued to practice until at least August 13, 2001. Practice on a

lapsed license constitutes a violation of Ohio Revised Code Section 4757.36(A)(1) and Ohio Administrative Code Section 4757-7-02.

4. **RODKEY-BAILEY** ADMITS the allegations referenced in paragraphs 2-3 referenced above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal disciplinary proceedings, **RODKEY-BAILEY** knowingly and voluntarily agrees with **BOARD** to the following terms and conditions:

1. **RODKEY-BAILEY'S** license to practice social work is hereby **REPRIMANDED**.
2. **RODKEY-BAILEY** must complete six (6) Continuing Education Units in addition to the 30 required for license renewal. Said six (6) Continuing Education Units must be in the area of professional ethics and be pre-approved by the **BOARD**. **RODKEY-BAILEY** is required to submit proof of completion of all 36 Continuing Education Units to the **BOARD**. Verification of completion shall be mailed to the attention of the Investigative Supervisor. This requirement must be completed no later than July 18, 2003.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **CONSENT AGREEMENT**, **RODKEY-BAILEY** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **RODKEY-BAILEY** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.

If, following notice and an evidentiary hearing, not an Ohio Revised Code Chapter 119 hearing, **RODKEY-BAILEY** is found by the **BOARD** to have violated any terms of this Consent Agreement, the **BOARD** may impose any penalty up to and including **REVOCAION** of **RODKEY-BAILEY'S** social work license based solely upon a violation of this Consent Agreement. **RODKEY-BAILEY** may not appeal this action.

RODKEY-BAILEY hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61 and Ohio Revised Code Section 2301.373(E), the

BOARD may be required to provide **RODKEY-BAILEY'S** social security number to requesting governmental agencies.
