THE BOARD ENTERED A CONSENT AGREEMENT WITH JONES WHICH REQUIRES SHE COMPLETE AN ADDITIONAL 6 HOURS OF CEU'S IN ETHICS. Ms. Jones completed the terms of the consent agreement as of 1/31/2007.

**CONSENT AGREEMENT
BETWEEN
DIONNE E. JONES
AND THE**

**STATE OF OHIO COUNSELOR, SOCIAL WORKER, AND MARRIAGE AND
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between DIONNE E. JONES, hereinafter, "**JONES**", and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, AND MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "**BOARD**", the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated thereunder.

JONES hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the **BOARD** or any of its members, employees or agents.

JONES is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. Should **JONES** fail to comply with any provisions of this CONSENT AGREEMENT, **JONES** knowingly waives her rights under ORC Chapter 119.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. On September 28, 2005, the **BOARD** received **JONES'** application for license as a Social Worker. As part of her application, **JONES** stated she was a Social Worker II at an agency in Cleveland, Ohio, where she did intakes and assessments. **JONES** met with a representative of the Social Worker Professional Standards Committee to clarify her actions previous to making application.
2. **DIONNE** admits the statements referenced in paragraph 1 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal disciplinary proceedings, **JONES** knowingly and voluntarily agrees with **BOARD** to the following terms and conditions:

1. **JONES** will be granted a Social Work license once she agrees to this proposal by signing it and returning it to the **BOARD'S** Deputy Director. **JONES** must take 6 hours of continuing education in the area of professional social work ethics in addition to the normal 30 hour renewal requirements. These 6 hours of continuing education must be pre-approved by the **BOARD'S** Deputy Director or his designee. All costs associated with this requirement are borne by **JONES**. **JONES** will have until January 31, 2007, to complete these additional 6 hours of continuing education. After completion of these 6 additional hours by January 31, 2007, **JONES** must send copies of her attendance certificate(s) to the **BOARD'S** Deputy Director.

It is hereby agreed by and between both parties that this CONSENT AGREEMENT hereby settles all issues concerning this matter.

By her signature on this CONSENT AGREEMENT, **JONES** acknowledges that in the event the **BOARD**, in its discretion, does not approve this CONSENT AGREEMENT, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **JONES** agrees that should the **BOARD** reject this CONSENT AGREEMENT and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this CONSENT AGREEMENT or of any information relating thereto.


JONES hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61, and Ohio Revised Code 3123.41 et seq the **BOARD** may be required to provide **JONES'** social security number to requesting governmental agencies.

The **BOARD** shall incorporate this CONSENT AGREEMENT into a formal journal entry at its January 20, 2006, meeting.

This CONSENT AGREEMENT shall take effect upon the date of the last signature below:


