This CONSENT AGREEMENT is entered into by and between LISA A. PADGETT, hereinafter, "PADGETT," and the STATE OF OHIO COUNSELOR, SOCIAL WORKER AND MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "BOARD," the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

PADGETT hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

PADGETT is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulation, admission and understanding:

1. PADGETT is a licensed social worker (S.0600838) licensed in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. PADGETT received her social work license on November 17, 2006.
2. Between March and August of 2014, PADGETT, while employed by a community mental health and recovery center in West Union, OH, failed to maintain appropriate boundaries with clients. This inappropriate conduct constitutes a violation of Ohio Revised Code Section 4757.36(C) (1) and Ohio Administrative Code Sections 4757-5-02(A)(2)
3. PADGETT ADMITS the allegation referenced in paragraph 2 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, PADGETT knowingly and voluntarily agrees with the BOARD to the following terms and conditions:

1. **PADGETT'S** license to practice social work is hereby suspended for three (3) years beginning March 20, 2015 through March 20, 2018. It is **PADGETT'S** responsibility to renew her license when appropriate if she intends to return to practice.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **CONSENT AGREEMENT**, **PADGETT** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **PADGETT** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto. Should the licensee fail to comply with any provisions of this consent agreement, the Board in its discretion, may initiate further disciplinary action pursuant to OAC 4757-11-01C (21).

PADGETT hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. All parties to this Consent Agreement understand that this information will be sent to the United States Department of Health and Human Services' National Practitioner Data Bank 9NPDB0, pursuant to Title IV of Public Law 99-660, the Healthcare Quality Improvement Act of 1986, as amended; Section 1921 of the Social Security Act; and Section 1128E of the Social Security Act, as amended by Section 221(a) of the Health Insurance Portability and Accountability Act of 1996. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61 and Ohio Revised Code Section 2301.373(E), the **BOARD** may be required to provide **PADGETT'S** social security number to requesting governmental agencies.

The **BOARD** shall incorporate this **CONSENT AGREEMENT** into a formal journal entry at its March, 2015 meeting.

PADGETT received her social worker license on November 17, 2006.
2. Between January 2007 and June 2007, while employed with a mental health agency in West Union, Ohio, PADGETT failed to maintain appropriate boundaries with a client. This action constitutes a violation of O.R.C. 4757.36 (A)(1) and O.A.C. 4757-5-02 (A)(2).
3. PADGETT admits the allegation referenced in paragraph 2.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, PADGETT knowingly and voluntarily agrees with the BOARD to the following terms and conditions:

Consent Agreement between Lisa Padgett and the State of Ohio Counselor, Social Worker, Marriage and Family
Therapist Board

1. **PADGETT** must work under supervision for eighteen (18) months with a minimum of one hour of face-to-face supervision per week or two hours of face-to-face supervision, two times per month, beginning on the date that the supervisor is approved. The supervisor must be pre-approved by the Board Deputy Director or his designee. The supervisor must submit quarterly reports regarding the supervision. Supervision should focus on, but not be limited to, areas of concern, areas for improvement, record keeping practices, and ethical decision making. Quarters consist of the following dates: Jan.-Mar, Apr.-Jun., Jul.-Sept., and Oct.-Dec. In order to meet the requirements of this agreement the reports must be received for each quarter. If **PADGETT'S** supervisor is concerned with **PADGETT'S** practice at any time the Board should be notified immediately. **PADGETT** is responsible for the submission of the reports to the Board. All cost associated with the supervision is the responsibility of **PADGETT**. Once **PADGETT** successfully completes this supervision, **PADGETT** must ensure verification of completion is sent to the attention of the Investigation Unit at the Board office.
2. **PADGETT** must take an additional six (6) hours in social worker ethics continuing education. All hours must be pre-approved by the Board's Deputy Director or his designee. Once **PADGETT** successfully completes this continuing education, **PADGETT** must send verification directly to the attention of the Investigation Unit at the Board office. The certificates verifying completion are due in the Board office no later than July 18, 2009. The credit earned from the workshops may not be used toward the thirty (30) hours of continuing education required for license renewal. All costs associated with the continuing education are at the expense of **PADGETT**.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **CONSENT AGREEMENT**, **PADGETT** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **PADGETT** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.





The BOARD shall incorporate this CONSENT AGREEMENT into a formal journal entry at its March 19, 2009, meeting.


