

**CONSENT AGREEMENT

This CONSENT AGREEMENT is entered into by and between KAREN J. MICKA, hereinafter, "**MICKA**", and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, AND MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "**BOARD**", the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated thereunder.

**MICKA** hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the **BOARD** or any of its members, employees or agents.

**MICKA** is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. Should **MICKA** fail to comply with any provisions of this CONSENT AGREEMENT, **MICKA** knowingly waives her rights under ORC Chapter 119.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. On January 17, 2007, the **BOARD** received **MICKA'S** application for licensure as a Social Worker. As part of her application, **MICKA** stated in a resume that she was an "L.S.W." which is a credential she did not possess at the time.
2. **MICKA** admits the statements referenced in paragraph 1 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any formal disciplinary proceedings, **MICKA** knowingly and voluntarily agrees with **BOARD** to the following terms and conditions:

1. The **BOARD** will grant **MICKA** a Social Work license at its May 2007 meeting. **MICKA'S** license to practice social work will then be suspended for a period of two (2) weeks from May 18, 2007, through June 1, 2007.

It is hereby agreed by and between both parties that this CONSENT AGREEMENT hereby settles all issues concerning this matter.


By her signature on this CONSENT AGREEMENT, MICKA acknowledges that in the event the BOARD, in its discretion, does not approve this CONSENT AGREEMENT, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. MICKA agrees that should the BOARD reject this CONSENT AGREEMENT and if this case proceeds to hearing, she will assert no claim that the BOARD was prejudiced by its review and discussion of this CONSENT AGREEMENT or of any information relating thereto.

MICKA hereby releases the members of the BOARD, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61, and Ohio Revised Code 3123.41 et seq the BOARD may be required to provide MICKA'S social security number to requesting governmental agencies.


The BOARD shall incorporate this CONSENT AGREEMENT into a formal journal entry at its May, 2007, meeting.
