

Rachel Luma completed the terms of the consent agreement as of 2/15/2013

**CONSENT AGREEMENT
BETWEEN
RACHEL M. LUMA
AND THE
STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between RACHEL M. LUMA, hereinafter, "LUMA," and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "BOARD," the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

LUMA hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents.

LUMA is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, based on the Board's investigation, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT. This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. LUMA is a social worker (S.0700902) licensed to practice social work in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Chapter 4757 and Ohio Administrative Code Chapter 4757. LUMA received her social work license on August 27, 2007.
2. LUMA renewed her social work license through August 27, 2011. In October 2009, LUMA was audited for compliance with continuing education requirements. LUMA was able to provide proof of 8.5 hours of the 30 hours needed to have renewed her license. LUMA'S failure to comply with the audit requirement constitutes a violation of Ohio Revised Code Section 4757.36(C) (1) and Ohio Administrative Code Section 4757-11-01 (C)(20)(b).
3. LUMA admits the allegation referenced in paragraph 2 above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, LUMA knowingly and voluntarily agrees with the BOARD to the following terms and conditions:

Consent Agreement between Rachel M. Luma and the State of Ohio Counselor, Social Worker, Marriage and Family Therapist Board

LUMA'S license to practice social work (S.0700902) in Ohio is indefinitely suspended. Once LUMA obtains 21.5 hours of appropriate social work continuing education, she must submit the completion certificates to the Board's Deputy Director for review. The BOARD will lift the licensure suspension once these hours have been reviewed and approved. These 21.5 hours may not be used for any future renewal.

It is hereby agreed by and between both parties that this CONSENT AGREEMENT hereby settles all issues concerning this matter.

By her signature on this CONSENT AGREEMENT, LUMA acknowledges that in the event the BOARD, in its discretion, does not approve this CONSENT AGREEMENT, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. LUMA agrees that should the BOARD reject this CONSENT AGREEMENT and if this case proceeds to hearing, she will assert no claim that the BOARD was prejudiced by its review and discussion of this CONSENT AGREEMENT or of any information relating thereto.

LUMA hereby releases the members of the BOARD, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61, and Ohio Revised Code 3123.41 et seq., the BOARD may be required to provide LUMA'S social security number to requesting governmental agencies. The BOARD shall incorporate this CONSENT AGREEMENT into a formal journal entry at its March 18, 2010, meeting.

This CONSENT AGREEMENT shall take effect upon the date of the Board Chair's signature below:
