## **Updates**

### **New Board Members**

Please welcome Ryan Pickut, LPCC-S and Anna Bomas, LSW, to the Board. As of the date of this report, we have two remaining vacancies – 1 public SWPSC member and 1 professional member of the MFTPSC.

### **Staffing**

Simeon Frazier will be replacing Doug Warne. We will be seeking a replacement for Simeon.

### **IT Assessment**

In late November, DAS OIT staff will be conducting an assessment of the Board's IT needs. I hope this assessment allows us to implement Office 365, which would enable us to implement our telework policy more easily, as well as facilitate other efficiencies.

### **Meeting with Deans and Chairs**

Thursday, November 12, I met with the leaders of the Social Work programs at OU, Akron, Wright State, Ohio State, Cleveland State, Case Western Reserve, and Cincinnati. Staff of NASW were also in attendance. The program administrators would like to explore changing the Board's policy regarding when Social Workers may take the clinical exam. They are asking that we follow the ASWB policy that requires two year of post-Master's practice before taking the clinical exam. I plan to schedule a meeting of stakeholders for the January meeting.

### **NASW SOCE Presentation**

Charlie Knerr and I were in attendance at a meeting arranged by NASW with Jim Struve, a Utah-based Social Worker who has been involved with a group of stakeholders discussing SOCE. Mr. Struve presented a unique approach to the issue of OCE. The group of which he is a part includes professionals and activists from both "sides" of the issue.

### **ASWB Delegates Meeting**

Andy Miller and I attended the ASWB Delegates meeting. I had good conversations with neighboring boards regarding reciprocity/mobility. ASWB did share that they are reviewing how the exam is used by boards. If ASWB decides to take a firmer line regarding who can take exams, e.g. requiring two years of practice before taking the clinical exam, Ohio may have to revise its policy.

### **HB 184 – Music Therapy**

I notified Representatives Dovilla and Antonio of the Board's decision regarding adding music therapy to this Board. I have not had any follow up regarding the decision.
