1. **Meeting Called to Order**

Dr. McGloshen called the meeting to order at 9:19 a.m.

2. **Discussion/Approval of Agenda**

A motion was made by Mr. Robertson to approve the agenda, seconded by Mr. McTigue. Motion carried.

3. **Approval of January 2012 Minutes**

A motion was made by Mr. Robertson to approve the minutes of the January 2012 Board meeting, seconded by Mr. McTigue. Motion carried.

4. **Approval of Applications for Licensure**

**5. Review of Examination Requests**

The Committee reviewed and approved 2 requests for licensing examination.

**6. Review of Supervision Hardship Request**

The members reviewed multiple requests for supervision hardship. One of the requests was approved to allow supplemental training hours with an additional supervisor. More information was requested from two individuals. Two of the requests involved an appeal to use retroactive hours accumulated; these requests were denied. Another request involved the desire to use hours before the eligibility date of a training supervisor; this request was denied.

**7. Discussion Issues - MFT License**

- The Committee requested the section pertaining to the temporary MFT license be removed from the statute. The hope is that this change can be added to the current pending bill that involves other Board statute changes.
- The Committee would like to move forward with a draft rule creating a supervisory designation for the IMFTs. The MFT Coordinator was tasked to draft this rule.

**8. Director's Report to the Committee**

Mr. Rough, Executive Director, gave his report to the MFTPSC.

- Mr. Rough discussed all current legislation relevant to the Board. The Board has identified sponsorship within the legislature, Rep. Sears, to introduce the proposed statute changes, including the MFT trainee status. A draft bill should be coming forthwith.
- The Board is still awaiting re-appointments for several positions, including two positions on this committee (the public member and another MFT licensee). It was expected that the Governor's office would have this task completed by the March meeting but that did not occur.
- The new staff position of CE Audit Coordinator has been filled by current receptionist Paula Broome. An applicant has been hired for the receptionist vacancy with a projected start date of March 26.
- The new rules will go into effect April 1 which include adding fees for replacement wall certificates and CE program/provider applications.
- Mr. Rough is waiting to hear back from Xavier University regarding a potential MFT curriculum in the Counseling Department.
- Committee members were reminded to complete their Financial Disclosure Filing with the Ohio Ethics Commission.

9. **Working Meeting**

The MFTPSC proceeded with a working meeting to review CEU Programs and Providers.
