Also clarified is Social Worker supervision courses do not count toward the renewal of a supervisory designation of an IMFT.

Old Business

HB 232 rules

- 4757-5-12 Rule regarding fee schedule in place of PDS
 - To avoid confusion, the MFTPSC agreed to leave this subject to the professional organizations to handle fee schedule examples for licensees rather than try to codify examples into a rule.
- 4757-7-03 Inactive status
 - Committee made a few language changes for clarity and consistency, including adding the word “process” to the title of the rule; under paragraph (A) removing the word “active”; and under (B) (6) changing the word “restoral” to “restoration.” A revised draft was given to the Executive Director.
- 4757-1-05 License Fees
 - Language changes were made for clarity and consistency and a revised draft was given to the Executive Director.
- 4757-1-08 Rule that relates to Veterans
 - Committee reviewed and agreed it was sufficient provided that the section pertaining to continuing education was consistent with the current language in rule 4757-7-01 regarding continuing education provisions for veterans.

3. Working Meeting

The MFTPSC proceeded with a working meeting to review CEU Programs and Providers.
