3. Offer consent agreement to Marion Meachem.

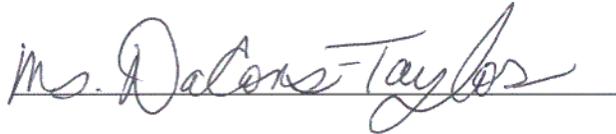
Mr. Abraham will attend the CLEAR conference in October.
