

CONSENT AGREEMENT
BETWEEN
HEATHER M. HOLLAND-SCHROEDER
AND THE
STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND
FAMILY THERAPIST BOARD

This CONSENT AGREEMENT is entered into by and between Heather M. Holland-Schroeder, hereinafter, "**HOLLAND-SCHROEDER**", and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "**BOARD**", the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated thereunder.

HOLLAND-SCHROEDER hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the **BOARD** or any of its members, employees or agents.

HOLLAND-SCHROEDER is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues, which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

The CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

1. On January 6, 2016, **HOLLAND-SCHROEDER** applied for a license as a licensed professional clinical counselor.
2. **HOLLAND-SCHROEDER** previously held a professional clinical counselor license that was revoked in July 2010.
3. **HOLLAND-SCHROEDER** admits the statements referenced above.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of other formal hearing proceedings, **HOLLAND-SCHROEDER** knowingly and voluntarily agrees with **BOARD** to the following terms and conditions:

1. The **BOARD** will license **HOLLAND-SCHROEDER** as a licensed professional counselor (LPC). **HOLLAND-SCHROEDER** will have to re-accomplish the two years of supervised experience required to become a licensed professional clinical counselor pursuant to Ohio Administrative Code Section 4757-17-01.
2. **HOLLAND-SCHROEDER** is not permitted to be in private practice as a licensed professional counselor

It is hereby agreed by and between both parties that this CONSENT AGREEMENT settles all issues concerning this matter.


By her signature on this CONSENT AGREEMENT, **HOLLAND-SCHROEDER** acknowledges that in the event the **BOARD**, in its discretion does not approve this CONSENT AGREEMENT, this settlement offer is withdrawn and shall be no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **HOLLAND-SCHROEDER** hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.

This CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. All parties to this Consent Agreement understand that this information will be sent to the United States Department of Health and Human Services' National Practitioner Data Bank (NPDB), pursuant to Title IV of Public Law 99-660, the Healthcare Quality Improvement Act of 1986, as amended; Section 1921 of the Social Security Act; and Section 1128E of the Social Security Act, as amended by Section 221(a) of the Health Insurance Portability and Accountability Act of 1996.

The **BOARD** shall incorporate this CONSENT AGREEMENT into a formal journal entry at its next meeting following the approval of this agreement.

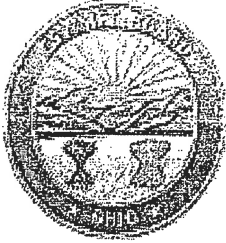

ADJUDICATION ORDER

IN THE MATTER OF THE ELIGIBILITY OF HEATHER HOLLAND TO MAINTAIN LICENSURE AS A PROFESSIONAL CLINICAL COUNELOR IN THE STATE OF OHIO.

THE MATTER OF HEATHER HOLLAND CAME BEFORE THE COUNSELOR PROFESSIONAL STANDARDS COMMITTEE OF THE OHIO COUNSELOR, SOCIAL WORKER, AND MARRIAGE AND FAMILY THERAPIST BOARD ON JULY 15, 2010.

This matter came for consideration after a Notice of Opportunity for Hearing was issued to Heather Holland by the Counselor, Social Worker, and Marriage and Family Therapist Board on February 18, 2010. An administrative hearing was held on May 12, 2010, and reconvened on June 9, 2010, in the offices of the Ohio Counselor, Social Worker, and Marriage and Family Therapist Board, 50 West Broad Street, Columbus, Ohio 43215, pursuant to Chapter 119 and Section 4757 of the Ohio Revised Code. The State was represented by Assistant Attorney General Leah V.B. O'Carroll. Heather Holland was not present and not represented by counsel.

FINDINGS, ORDER, AND JOURNAL ENTRY

The Counselor Professional Standards Committee has reviewed the Hearing Officer Report and Recommendations prepared in this case following the administrative hearing. The evidence was made available to the Committee to review. The Committee finds that Ms. Holland violated Ohio Revised Code Section 4757.36(A)(1) and Ohio Administrative Code Sections 4757-5-09(G) and 4757-5-02(A)(2) since Ms. Holland did not maintain the appropriate standards of care expected of a licensed professional clinical

counselor and acted in a fraudulent manner. The Committee accepts the Findings of Fact and Conclusions of Law presented in the Hearing Officer Report and Recommendations in their entirety. The Committee also accepts the Recommended Order of the Hearing Officer and orders that the professional clinical counselor license (E.0007865) of Heather Holland is Revoked.

This ORDER was approved by unanimous vote of the Members of the Committee who voted on this case. Dr. Susan Huss recused herself from the vote and did not participate in any discussion of the case.


Motion carried by order of the Counselor Professional Standards Committee of the Ohio Counselor, Social Worker, and Marriage and Family Therapist Board.

APPEAL RIGHTS

Under the provisions of Ohio Revised Code Section 119.12, any party adversely affected by an order of an agency issued pursuant to an adjudication denying an applicant admission to an examination, or denying the issuance or renewal of a license or registration of a license, or revoking or suspending a license, may appeal from the order of the agency to the court of common pleas of the county in which the place of business of the licensee is located or the county in which the licensee is a resident. If any such party is not a resident of and has no place of business in Ohio, the party may appeal to the court of common pleas of Franklin County

This *Order* may be appealed in accordance with Section 119.12 of the Ohio Revised Code by filing the original Notice of Appeal with the Ohio Counselor, Social Worker, and Marriage and Family Therapy Board, 50 West Broad Street, Suite 1075, Columbus, Ohio 43215, and also a copy of that Notice of Appeal with the Court of Common Pleas in the county of the party's place of business, or in the county in which the party is a resident. The Notice of Appeal shall set forth the Order appealed from and the grounds of the Party's appeal. Such Notice of Appeal and copy shall be filed and must be delivered within fifteen (15) days after the mailing of this *Adjudication Order*.

This CONSENT AGREEMENT is entered into by and between **HEATHER HOLLAND**, hereinafter, "**HOLLAND**" and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "**BOARD**" the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

HOLLAND hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents. **HOLLAND** is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT. Should **HOLLAND** fail to comply with any provisions of this CONSENT AGREEMENT, **HOLLAND** knowingly waives her rights under ORC Chapter 119.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations and, understandings:

1. **HOLLAND** is a professional clinical counselor (E-0007865) licensed to practice counseling in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of counseling as outlined in Ohio Revised Code Section 4757 and Ohio Administrative Code Chapter 4757. **HOLLAND** received her clinical counselor license on July 21, 2006.
2. **HOLLAND** falsified her educational qualifications on an application to become an approved provider for Alliance Partners Credentialing, in 2007. This action constitute a violation of O.R.C. 4757.36 (A) (1) and O.A.C. 4757-5-02 (A) (1).
3. **HOLLAND** admits the allegations referenced in paragraph 2.

Therapist Board

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, **HOLLAND** knowingly and voluntarily agrees with the **BOARD** to the following terms and conditions:

1. **HOLLAND** must work under supervision for eighteen months (18) with a minimum of one hour of face-to-face supervision per week or two hours of face-to-face supervision, two times per month, beginning on the date that the supervisor is approved. The supervisor must be pre-approved by the Board Deputy Director or his designee. The supervisor must submit quarterly reports regarding the supervision. Supervision should focus on, but not be limited to, areas of concern, areas for improvement, record keeping practices, and ethical decision making. Quarters consist of the following dates: Jan.-Mar, Apr.-Jun., Jul.-Sept., and Oct.-Dec. In order to meet the requirements of this agreement the reports must be received for each quarter. If **HOLLAND'S** supervisor is concerned with **HOLLAND'S** practice at any time the Board should be notified immediately. **HOLLAND** is responsible for the submission of the reports to the Board. All cost associated with the supervision is the responsibility of **HOLLAND**. Once **HOLLAND** successfully completes this supervision, **HOLLAND** must ensure verification of completion is sent to the attention of the Investigation Unit at the Board office. During the period of time this consent agreement is in effect, **HOLLAND** is not eligible to obtain the supervision designation.
2. **HOLLAND** must take an additional six (6) hours in counselor ethics continuing education. All hours must be pre-approved by the Board's Deputy Director or his designee. Once **HOLLAND** successfully completes this continuing education, **HOLLAND** must send verification directly to the attention of the Investigation Unit at the Board office. The certificates verifying completion are due in the Board office no later than October 16, 2008. The credit earned from the workshops may not be used toward the thirty (30) hours of continuing education required for license renewal. All costs associated with the continuing education are at the expense of **HOLLAND**.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.

By her signature on this **CONSENT AGREEMENT**, **HOLLAND** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **HOLLAND** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the


BOARD was prejudiced by its review and discussion of this CONSENT AGREEMENT or of any information relating thereto.

The **BOARD** shall incorporate this CONSENT AGREEMENT into a formal journal entry at its July, 2008, meeting.




