

**CONSENT AGREEMENT  
BETWEEN  
PEGGY DAVENPORT  
AND THE  
STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND  
FAMILY THERAPIST BOARD**

This CONSENT AGREEMENT is entered into by and between **PEGGY DAVENPORT**, hereinafter, "**DAVENPORT**" and the STATE OF OHIO COUNSELOR, SOCIAL WORKER, MARRIAGE AND FAMILY THERAPIST BOARD, hereinafter "**BOARD**" the state agency charged with enforcing Chapter 4757 of the Ohio Revised Code and all rules promulgated therein.

**DAVENPORT** hereby acknowledges that she has read and understands this CONSENT AGREEMENT and has voluntarily entered into it without threat or promise by the BOARD or any of its members, employees or agents. **DAVENPORT** is fully aware of her rights, including her right to be advised by counsel and her right to a hearing pursuant to Chapter 119 of the Ohio Revised Code on the issues which are the subject of this CONSENT AGREEMENT.

This CONSENT AGREEMENT contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this CONSENT AGREEMENT.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations and, understandings:

1. **DAVENPORT** is an independent social worker (I-0700253-S) licensed to practice social work in the State of Ohio, and is subject to the laws and rules of Ohio regulating the practice of social work as outlined in Ohio Revised Code Section 4757 and Ohio Administrative Code Chapter 4757. **DAVENPORT** received her social worker license with supervision designation on October 16, 2007.
2. Beginning in November, 2011, and January 2012, **DAVENPORT** was in private practice in Madison, Ohio, and entered into a sexual relationship with two recently terminated clients. This action constitutes a violation of O.R.C. 4757.36 (C)(1) and O.A.C. 4757-5-04 (C).
3. **DAVENPORT** admits the allegation referenced in paragraphs 2.

Wherefore, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any other formal disciplinary proceedings, **DAVENPORT** knowingly and voluntarily agrees with the **BOARD** to the following terms and conditions:

Consent Agreement between Peggy Davenport and the State of Ohio Counselor, Social Worker, Marriage and Family Therapist Board

The **BOARD** will allow **DAVENPORT** to surrender her social worker license in lieu of other potential disciplinary action. **DAVENPORT** is prohibited from re-applying for licensure as a social worker, counselor or marriage and family therapist in the State of Ohio prior to three years of the effective surrender date.

It is hereby agreed by and between both parties that this **CONSENT AGREEMENT** hereby settles all issues concerning this matter.


By her signature on this **CONSENT AGREEMENT**, **DAVENPORT** acknowledges that in the event the **BOARD**, in its discretion, does not approve this **CONSENT AGREEMENT**, this settlement offer is withdrawn and shall be of no evidentiary value and shall not be relied upon or introduced in any disciplinary action or appeal by either party. **DAVENPORT** agrees that should the **BOARD** reject this **CONSENT AGREEMENT** and if this case proceeds to hearing, she will assert no claim that the **BOARD** was prejudiced by its review and discussion of this **CONSENT AGREEMENT** or of any information relating thereto.

**DAVENPORT** hereby releases the members of the **BOARD**, its officers and employees, jointly and severally, from any and all liability arising from the matter within.


This **CONSENT AGREEMENT** shall be considered a public record as that term is used in Section 149.43 of the Ohio Revised Code. Pursuant to 42 USC Section 132a-73(b), 5 USC Section 552a, 45 CFR part 61, and Ohio Revised Code 3123.41 et seq., the **BOARD** may be required to provide **DAVENPORT'S** social security number to requesting governmental agencies.

The **BOARD** shall incorporate this **CONSENT AGREEMENT** into a formal journal entry at its July, 2012, meeting.




